**LOCATION**

The property is situated fronting Streatham High Road close to its junction with Leigham Court Road and very close to Streatham Hill overground station. Streatham High Road forms part of the main A23 commuter route and the property benefits from vast quantities of passing vehicular traffic particularly during the rush hour periods with a good deal of pedestrian flow generated by the nearby station and other trades in the vicinity including Townends estate agents and LA Fitness health club. The surrounding area is a densely populated residential catchment which the property is able to service including large numbers of flats, including mansion blocks in the immediate vicinity.

## **DESCRIPTION**

The property comprises a ground floor lock up shop most recently used as a fashion store but suitable for a variety of trades. The property has security shuttering across the entire frontage, slightly arcaded shop front, internal partitioning to create a good sized sales area, small store and some partitioned changing areas. The property has a suspended ceiling with some spotlighting and a raised platform within the shop front for display purposes. The property has rear access to a communal alleyway.
